The conference was inaugurated by Hon'ble Justice K. Bhakthavathsala by lighting the lamp & putting the conference in order. In his inaugural address he spoke on "Machinery for Enforcement of Human Right in India & Interfaith Dialogue". He further said such conferences are very essential now a day to respect one another and basic rights of every human being. We should involve with youths and discuss about interfaith movement, mutual understanding between Religions, Peace , Tolerance & non violence, otherwise they may attract fanaticism, that is harmful to every nations in the world .He also shared the importance of the interfaith organizations initiatives for interfaith dialogue involving with various religious leaders locally, nationally and internationally .

Mr. Rengapashyam Nat'l president IARF IC has presided the conference & he said that in Andhra Pradesh –India there is tomb of Muslim saints where Hindus, Muslims & Christians come to prayer & there is a good Mutual understanding among all the religions. He said No Peace among the nations without Peace among the religions he also said no peace among the religions without dialogue among the religions. Further he said we live in globe village, which is Multi-religious and Multi-cultural.

Mr. H Vishwanth Hon'ble Member of Parliament of India, B K Chandrasekhar Ex Chairman Legislative & Ex Education Minister Govt of Karnataka, Rev. Thomas A. Vazhapilly Bishop of Mysore, Alijanab Moulana Usman Shariff Sahib Sir Khazi of Mysore, spoke on interfaith dialogue- The way to reconciliation more or less all the above mentioned dignitaries spoke on the same grounds they said the goal of archiving independence of India brought some of the Hindus & Muslims together. Nazi atrocities in Europe were greatly

responsible for post war generation to change the traditional Christians stands towards Judaism. Regional wars in Lebanon & former Yugoslavia have encouraged those societies to disarm religious hater ness. Moreover, the realization that if all religions can join together, they can make the solution to the challenges of globalization.

Dr. Homi B Dhalla spoke on <u>Interfaith Movement & on Dialogue</u>, he said we are aware of the fact that although religions have been a cause for many conflicts they have also been great reservoirs of spiritual wisdom fortunately; we are now gradually witnessing hopeful signs past barriers of distrust & Isolation being over come among religious traditions

History informs us that there have been instances of dialogue among the adherents of Islam, Judaism & Christianity after certain conflicts. These encounters took place in Medieval, Islamic, Spain & Southern Italy & different times in central Asia, Delhi, Baghdad, and Cairo & Ottoman Empire.

But inter religious dialogue as Movements with its specialists & activist is essentially a phenomenon of 20th century. Perhaps one of the earlier seats of inter religious Movements was the Parliament of world's religious which held in 1983 when swami Vivekananda went to Chicago & introduce the great treasure of Indian philosophy & thought to the Mile stone.

He also mentioned different types of dialogue. He basically there are four different types of dialogues which are as follows.

- 1. The first is <u>Dialogue of life</u>, where individuals & groups are expected to live harmoniously with their neighbours in there share their joys & sorrows & as well as their religious experiences & ideologies.
- 2. The second is <u>Dialogue of action</u> where people collaborate on common projects, which will beneficial to society. It emphasizes specific cooperation & joint action- for peace, justice, protection of the environment, defense of Human rights- as the way to bring harmony & unity among different religious communities.
- 3. The third is the <u>Dialogue of religious experience or spirituality</u>. This is form of dialogue where persons committed to their own religious share their spiritual experiences of prayer, meditation & faith with members of other tradition. This can be mutually enriching while promoting & preserving the spiritual & ideals of one's tradition.
- 4. The fourth is the <u>Dialogue Theological Exchange</u>. Here Specialists enter into mutual dialogue in order to enhance their understanding of the other tradition & share spiritual values. This form of dialogue as been held over the decades in many parts of the world among the different religious traditions. The religious scholar as a crucial part to play as he can examine the roots of discord & help the community to sort out these conflicts.

Dr. Thomas Mathew in his Key note address spoke on the Interfaith/Interfaith Dialogue which refer to cooperative & positive interaction b/w religious traditions & spiritual or humanistic beliefs, at both individual an institutional level with the aim of deriving a common in belief through a concentration on similarities b/w faiths, understanding of values & commitment to the world.

Today dialogue is used in class rooms, community centers, corporations, federal agencies, and other settings to enable people, usually in small groups, to share their perspectives & experiences about difficult issues. It is used to help people resolve long-standing conflicts & to built deeper understanding of contentious issues. Dialogue is not judging, weighing, or making decisions, but about understanding & learning. Dialogue dispels stereotypes, built stress & unable people to open to perspectives that are very different from their own.

Through out world there are local regional & international interfaith initiatives, many are formally or informally linked are constitute larger network or federations the often quoted "There will be no peace among the nations without peace among the religion. "There will be no peace among the religions without dialogue among the religions" was formulated by Dr Hans Kung a professor of Ecumenical Theology & President of foundation for a global Ethic.

Reconciliation means settlement, resolution, compromise, reunion, bringing together.

History of Interfaith Dialogue in brief:-

The history of interfaith is as ancient as the religions since men & woman when not at war with their neighbours have always made effort understand them (not least because understanding a strategy for defense, but also because for as long as there is dialogue wars are delayed). History records many examples of interfaith initiatives & dialogue throughout the ages.

What the world needs to know about interfaith dialogue covers a range practical & philosophical issue supplemented by anecdotal information. For example, it shows you:-

- 1. How to over come differences in theology & belief
- 2. Which projects will gain recognition interfaith groups
- 3. How to get religious literalists & liberals to cooperate
- 4. How to make interfaith meeting smoothly
- 5. How to defuse inter conflict
- 6. How to distinguish a religion from a cult
- 7. How to deal explosive political issues

What one can to do to make it happen?

- 1. Eradicate extreme poverty & hunger
- 2. Achieve universal primary education
- 3. Promote gender equality & empower women
- 4. Reduce child morality
- 5. Improve maternal health
- 6 .Combat HIV/AIDS, malaria & other diseases
- 7. Ensure environmental sustainability
- 8. Create global partnership for development with targets for aid, trade & debt relief.

US Institute of Peace:

Building personal relationship is fundamental to any reconciliation process. This requires time & space. Building relationship is more important than resolving particular issues or disputes & provides the basis for long term problem. The goal is transformation of relationship at a deep level.

Different sessions held on 20th after the inaugural programme.

The 1st was held by Dr. Homi B Dhalla on "Many Faces Of Peace". He made power point presentation were in different photographs involving peace activities in different parts of the world was shown ha explained how peace movement is being actively organized in the universe it was one hour session & the delegates were very happy made by Dr. Homi B Dhalla.

The 2nd session held by Mr. T. Ramakrishna Prof of law Chairman intellectual Property rights, Nat'l law school of India, University Bangalore, Bangalore area India spoke on "High Level Consultation on Conflicts, Violence & Peace"

The 3rd session was held by staff of suttur math by presenting a CD presentation on suttur math activities followed by cultural program organized by the students of JSS math, Moulana Azad B.Ed College, Teresian College & Animators of an NGO Organization for The Development of People (all from Mysore city & Mysore Dist)

During the General Meeting of the Chapter, the participants shared their view on religious freedom and stronger activities from IARF. They focused on present religious situation in India and the role of IARF on those issues. Members happily shared that HRE was one of the positive steps towards that role of IARF. The importance of closer relationship and programs like HRE are the needs of the hour. The Memebrs whole heartedly expressed their full support for the Congress and raise fund for the young Adults registration if it is a difficult for them.
