
# REPORT

#### Introduction

Vivekananda Seva Nikatan is a government registered nongovernment organization, founded with the mission to abolish injustice and inequality from the society and extend cooperation in both regional and global level. Their work is based on the idea of Swami Vivekananda and work especially for the underprivileged youth, children and the women. They heard about HRE program of IARF and came to IARF Kolkata office with a request to organize such workshop in their organization in collaboration with IARF, SACC for sensitizing local youth about Human Rights and their role. The organization had its own old office house with small garden of fruit trees. President of the organization, Dr. Ambika Ghosal inaugurated and graced the



occasion as president to the program and the secretary of the organization, Mr. Ashis Chatterjee grace the occasion as chief guest to the inaugural program. 14 girls and 18 boys attended the program from Hindu and Muslim communities. In spite of traditional orthodox family, two girls from same Muslim family also attended the program.

#### Main Aim

- o Sensitize people about the rights of freedom of religion and belief.
- Bring Religious Harmony and Peace in the society.

#### Objective

- Minimize socio-cultural and political conflict, violence and tension based on religious issues from the society.
- Eliminate all form of intolerance, humiliation and hatred through exchange of dialogue among different faith groups.

#### Methodology

Group works-discussions, lectures, case studies, Audio visual learning and group report presentation.

#### **Issues rose**

- o Hatred, humiliation, intolerance, Religious conflicts etc
- Rights to freedom of religion and belief

#### Assumptions

It's a rural area, people are not so aware about the idea of interfaith and the rights of freedom of religion and belief. Most of the participants will try to establish their own opinion based on their knowledge.

#### **Expected learning outcomes**

#### Short-term

Participants will be able to change their mind set up and will be oriented and motivated to accept the freedom of religion and beliefs as important human rights.

#### Long-term

All sorts of social violence, conflicts and tension will be solved.

#### **Resources Required**

Cooperation and man power support from the local organization Teaching and training materials- pad, pen, laptop, LCD Projector, flip charts, marker pen etc.

#### Language Problem

There was no language problem (Both English & Bengali were used).

#### Location

Vivekananda Seva Nikatan Narayanpur, Kankinara, Naihati, West Bengal

#### Have you already had contacted with this Institute?

#### Why have you chosen this community/target group?

Tension and misunderstanding present among the young generation of this area. It is a backward industrial area of West Bengal, 60 km away from Kolkata city. In order to resolve tensions and misunderstanding we have selected this area for organizing HRE workshop.

#### How did you ensure the balance of gender, ages etc?

It is an NGO, so both boys and the girls had attended the program. I asked the organization to select potential students of various faith groups for attending this HRE program. 18 boys and 14 girls attended the program from Muslim and Hindu communities.

## What steps have you undertaken to lessen the tension between the participants from different faith groups?

I inspired and insisted participants to maintain peace and to be calm and patient during discussion. They started free discussion with open mind instead of making loud voice and unhealthy discussions.
