Introduction:

Vivekananda Yuvak Sangha, is an NGO with Government registration, has been working since 1988 in the field of rural development. Agriculture and allied sector is their main focus of work along with human resource development.

Methodology

Group Discussions, lectures, case studies, Audio visual learning and group report presentation

Issues rose

- Social problems intolerance, tension, humiliation etc, and Social Change
- Human Rights and freedom of religion and belief
- UDHR and DIDRB

Assumptions

All participants were asked to present in all the sessions of two day program. After lectures all came up with open and broad mind to accept the cultural differences of individuals and groups

Expected learning outcomes

Short-term

Participants are able to change their mind set up and have been oriented or motivated towards positive attitude of life.

Long-term

All sorts of social violence, conflicts and tension will be resolved widely from the community.

Resources Required

Teaching kits and training materials, infrastructure, manpower, etc.

Language Problem

There was no language problem existed (Both English and Bengali were used)

Location

Vivekananda Yuvak Sangha, Jajur, Haripal, Hooghly, West Bengal.

Have you already had contact with this Institute?

Why have you chosen this community/ target group?

Tension and misunderstanding present among the young generation of Hindus and Muslim communities in Jejur area of Hooghly district. So facilitator felt that the target group here would be ideal to resolve this problem if they are rightly given with human rights and inter-faith insights.

How did you ensure the balance of gender, ages etc?

Before the commencement of workshop, prior to a week I had discussed the guidelines with the host NGO, who had sent students to attend the HRE program. As per the discussions the association selected 22 female and 14 male youth to participate the program from different faith communities between 18 to 26 years.

What steps have you undertaken to lessen the tension between the participants from different faith groups?

The facilitator had requested the participants to maintain calm and peace during discussion and insisted them to hold open and free discussion with mutual respect.


