



# Religious Representation



#### Introduction

Two day Human Rights Education program, sponsored by SACC, Kerala was held at NBM Law College, Maharanipeta, Visakhapatnam-02 on 12<sup>th</sup> & 13<sup>th</sup> October, 2012. The workshop was organised by B. V. Foundation for Peace and Harmony, a member group of IARF. 37 students both boys and girls of different faith communities attended the program along with the faculty of the College. Sri K. Suryarao, Senior Civil Judge and Secretary Legal Services authority inaugurated the programme. Dr. P. Sridevi, Principal of the College, graced the occasion. Prof. N. Prakasa Rao, spoke about IARF and the importance of organizing HREP. Miss. E.P. S. Bhagyalakshmi spoke about IARF's Statement of purpose. The NBM Law College is situated in Maharanipeta, 6 kilo meters away from the city. The participants are law students hence they have some knowledge about Human Rights in general, and on religious freedom right in particular.

#### Main Aim:

- Sensitize law students about the rights of freedom of religion and belief.
- Promote religious harmony and peace among difference communities of students.

#### **Objective:**

- To create awareness among the students about the need to minimize socio-cultural and political scuffle, conflict, violence and tension from the society.
- Eliminate all forms of intolerance, humiliation and hatred through exchange of dialogue among different faith groups and traditions.

### Methodology:

Participatory method - Group work - Discussions - Lectures - Case studies, Role play, Audio visual learning & Group Presentation.

#### **Issues Rose:**

Gender Discrimination, Human Dignity, hatred, suspecting each other, humiliation, intolerance, religious conflict, right to freedom of Religion and belief, etc.

# **Assumptions:**

All the participants will have to present in all the sessions of two days programme. After participation the group come with open and broad mind to accept each other and accept the cultural differences of individuals.

#### **Risk factors:**

It is a Law College and students have common interest. The group consists of Hindu's, Muslims, Jains, Christians. There exists a slight tension and risk among them with regard to religious freedom and beliefs but we could satisfy them conventionally till they satisfied.

#### **Outcomes:**

#### Short-term

Participants will be able to change their mind set up and will be motivated and oriented to accept the freedom of religion and beliefs as important as Human Rights. Also decided to celebrate all religious festivals.

# Long-term

To establish religious freedom clubs and all sorts of social scuffle, violence, conflict and tension will be resolved by understanding each other.

#### **Resources required:**

- Cooperation and man power from the local college where HREP was conducted.
- Supporting materials, pad, pen, LCD Projector, flipcharts, marker and pens were required.

# Language problem:

There was no language problem since all students are good in English. Most of the students follow English and rest follow Telugu as such no language problem.

### Why have you chosen this community/target group?

Since participants are future lawyers. Enriching with religious freedom right knowledge certainly we help to resolve religious conflict in particular and Human Rights in general. Therefore we have decided to organise the HREP work shop here.

# How did you maintain balance of gender and ages?

It is a co-educational College, so both male and female attended the programme (Male-16, Female-21) and the age group between 18-28 years. College authority selected 37 students of various faith groups for attending this HRE programme.

#### What are the steps have you taken to lessen the tension between the participants from different faith groups?

By and large there was not much tension between the participants from different faith groups when tension arises facilitators insisted participants to maintain peace and to be calm and patience during the discussion. They were given opportunity to start open & free discussion instead of loud voice. There was lively discussion on intra and inter religious, marriages, somehow we inspired the participants to understand issues with open mind and act.
