Deshbandhu Mahavidyalaya, Burdwan is an affiliate institution of the University of Burdwan and a registered academy of University Grants Commission imparts instructions on general degree courses in Science, Humanities and Commerce streams and professional degree courses in Advertising, Sales Promotion and Sales Management, BBA (Hons) & BCA (Hons).

The institute was established in 1973, under the aegis of Chittaranjan Locomotive Works, Hindustan Cables Ltd. and a group of philanthropists, it travelled a terrain of hard times and had landed, with the blessings of the Govt. of West Bengal, the U.G.C., the CLW, the HCL, the people of the



locality and many other well wishers, to a plateau ultimately. Deshabandhu Mahavidyalaya was established with the specific objective to cater to the need of Higher Education of the locality. This College has also the goal to develop healthy student - teacher relationship, to inculcate among students values that will help them live in harmony with the world at large and to help them become efficient members of the futuristic society. This College also does not ignore the imperative to generate employment as well as helping students to bring their learning bear upon every day of existence.

Chittaranjan is an industrial small town with Metropolitan Characters. People of different castes, classes, religions and languages live here, who once came here to work in Indian Railway locomotive Works centre and Hindustan Cables Ltd. Contemporary social and cultural problems are predominant in this industrial belt which leads to conflicts, discords or violence very often. Human Rights face resistance and in consequence human rights are being violated. Therefore, it is utmost important to sensitize local people about the important of Human Rights and the nature and types of violation of Human Rights, particularly the rights of religion and belief. Forty (40) participants attended the HRE program. Out of which 23 are girls and 17 are boys, including teachers.

Main Aim

- o To enhance and promote Religious Harmony & Human rights irrespective of religion, caste, sex, color etc. and enjoy all sorts of freedom in democracy which has led down by national Govt.
- Avoid social, cultural, political violence, intolerance & conflicts by accepting the differences of human beings.

Objective

- To educate, motivate and change the mind set up of the young people of different religious traditions about the rights of human beings & the concept of religion.
- To eliminate all form of intolerance through exchange of dialogue and enjoying religious freedom, human rights and dignity.
